

FSB Development's Pricelist for products and services

1. General

FSB Development offers products, consultancy services and training, cf. this price list. All prices are quoted in euro (\in) or DKK and are exclusive VAT. The prices are calculated on the basis of 1 Euro being equal to 7.50 DKK, but FSB Development reserves its right to adjust the prices quoted in euro at any time if the exchange rate differs from the above stated at the time of the Customer's purchase.

The normal working hours are Monday to Thursday from 09.30 AM to 05.00 PM and Friday from 09.30 AM to 03.00 PM (DK-time)

Unless otherwise agreed, consultancy services, performed on working days between 07.00-09.30 AM and between 05.00-10.00 PM (Fridays 03.00-10.00 PM), will be charged with additional payment of 50%. Weekends and between 10.00 PM and 07.00 AM and on holidays an additional payment of 100 % is charged.

Consultancy services and training are governed by FSB Development's at any time valid Standard Terms and Conditions.

2. Transport

Mileage allowance to and from the Customer's address is settled in accordance with the Danish Government's at any time current rates per driven kilometre. Travel costs and accommodation expenses, as well as mileage allowance, will be invoiced separately. In addition thereto transport hours will be charged in accordance with the price list. Unless otherwise agreed, transport and transport hours are calculated from the location where the consultant initiates the transport.

3. Training

FSB Development offers training and product certification, which can be held at the Business Partner, at the Customer, at a third party, at FSB Development premises or as Web training.

For company courses at the Business Partner, at Customer or at a third party address, transportation and mileage allowance will be invoiced separately to the Customer, cf. the above specified regulation of transport.

4. Retainer

On payment in advance FSB Development offers retainers on all consultancy services which are delivered on time and material basis. The retainer cannot be used as payment for transport, accommodation expenses, mileage allowance and training. Unless otherwise agreed, the retainer is valid for 12 months from the invoice date.

If the Customer requests purchase prices for Retainers these prices will be forwarded and in such case an agreement concerning purchase of a Retainer is entered into separately.

5. Payment

Any payment shall be made not later than 14 days after date of invoice. In case payment is not made in due time, default interest will accrue at FSB Development ApS ordinary rate. In case of delivery of the product to the customer's premises the customer shall pay all transports costs, including insurance.

6. Changes

FSB Development is entitled to adjust the price list once a year as of January 1.
